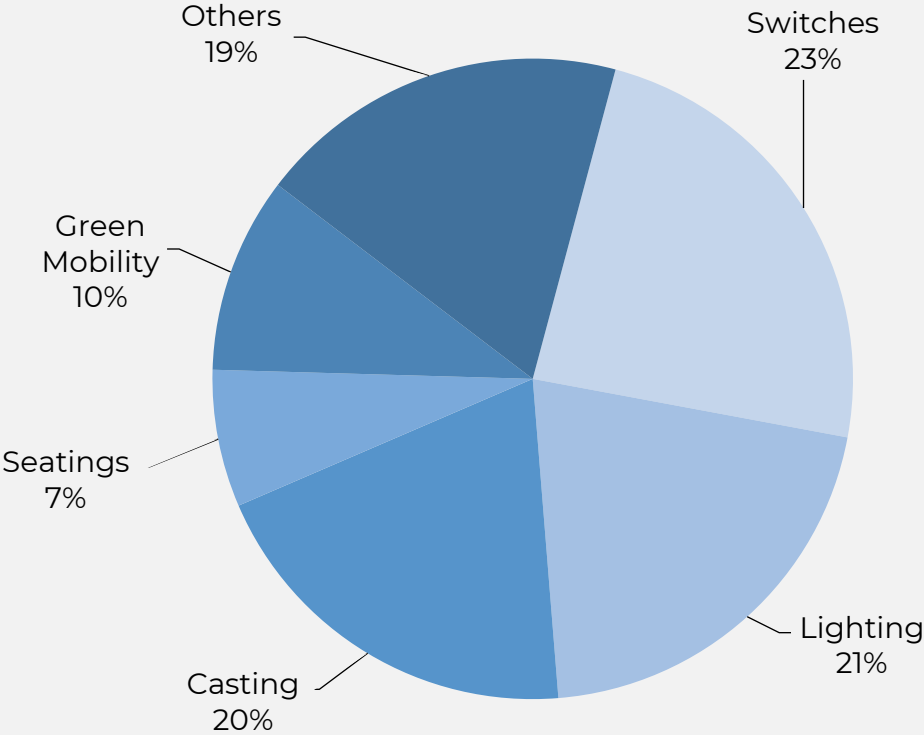


DIVISION-WISE REVENUE MIX

Q1 FY26 (%)



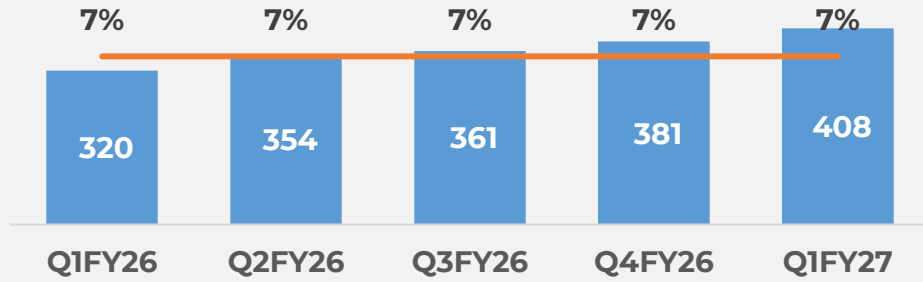
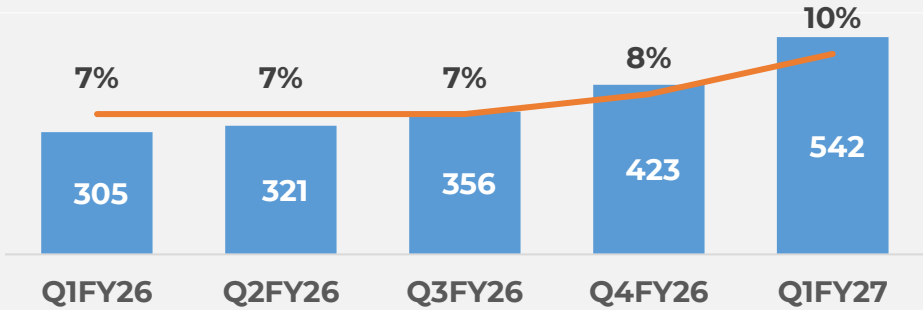
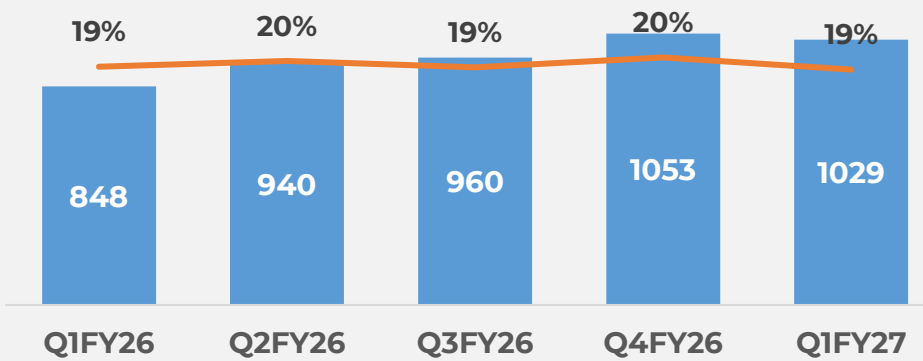

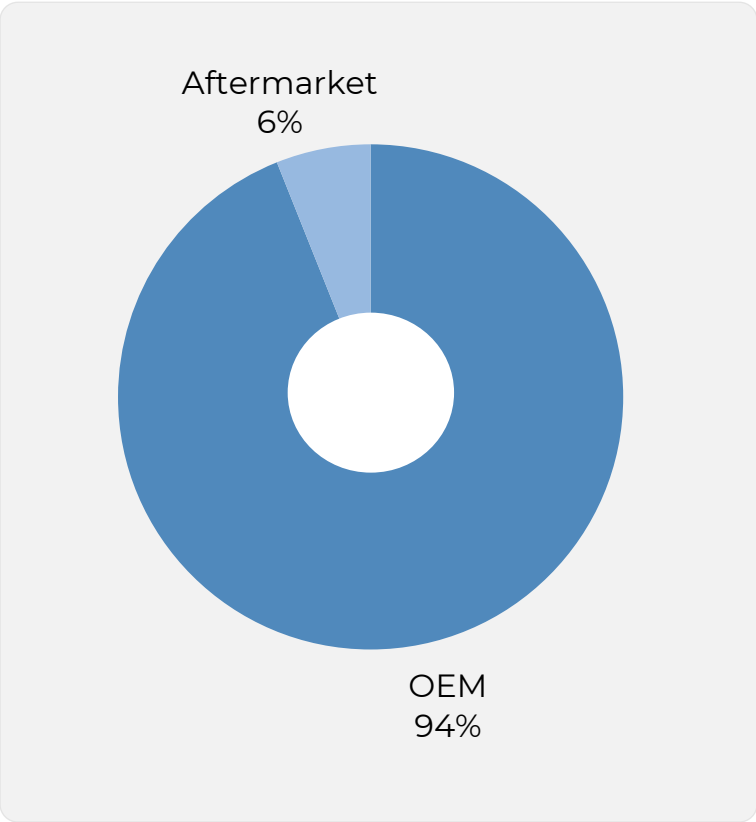

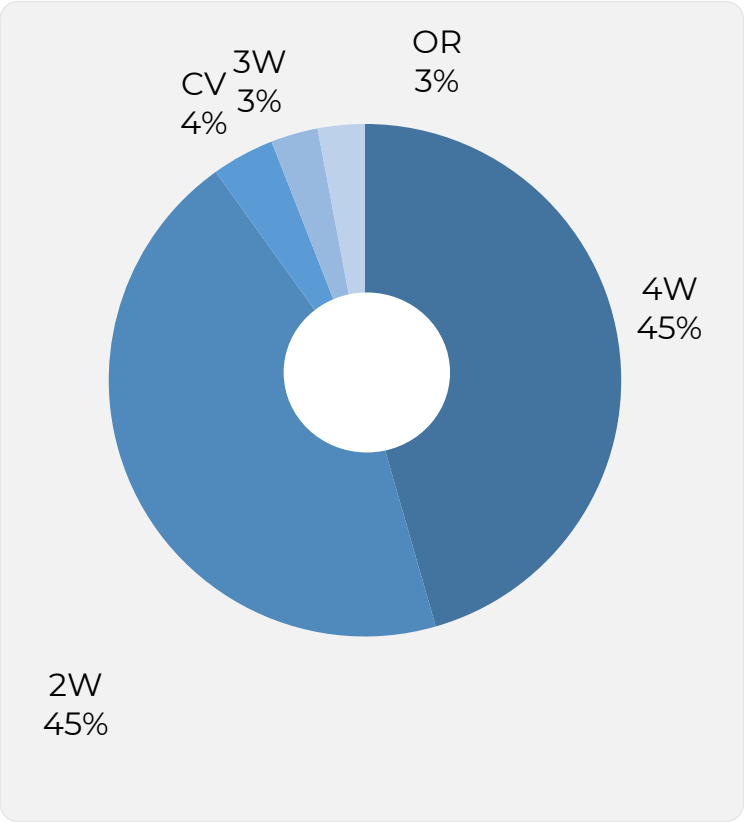
REVENUE BREAKUPS Q1 FY27

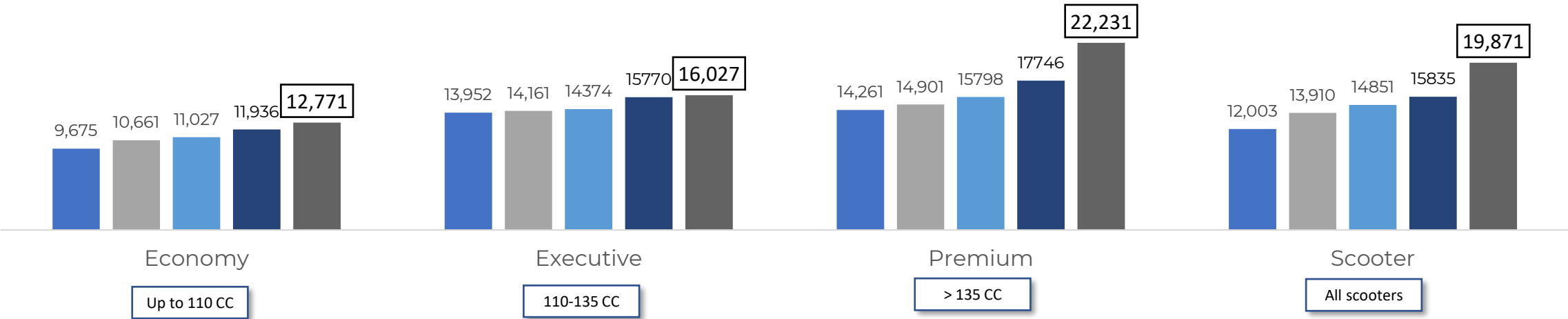

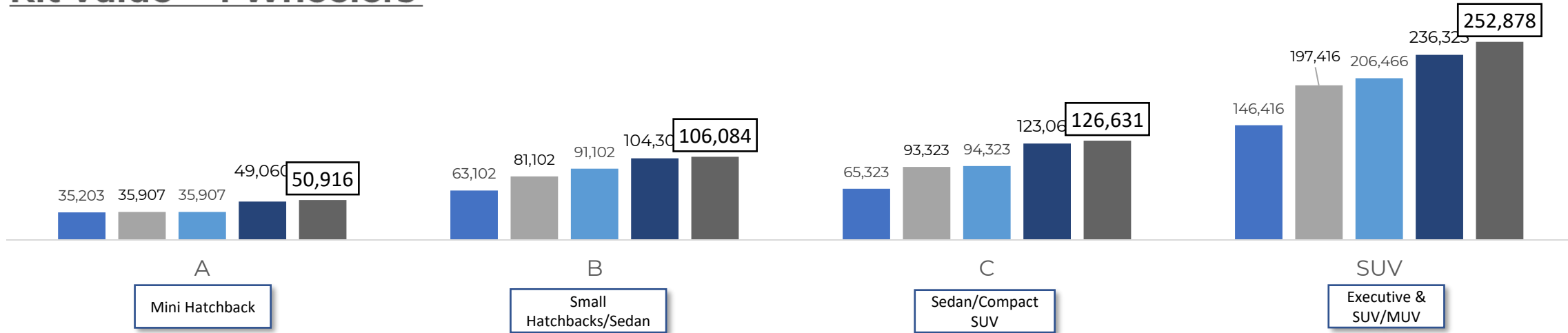
