Sub.: Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Completion of acquisition of certain power related assets and investments of Jaiprakash Associates Limited.

Ref: Our earlier intimation on the morning of May 21, 2026

We refer to our captioned intimation, whereby we had informed that Adani Power Limited ("**Company**") has entered into the following definitive agreements with Jaiprakash Associates Limited ("**JAL**") for the acquisition of its power-related assets and investments:

- (a) Share Purchase Agreement for acquisition of 24% shares of Jaiprakash Power Ventures Limited ("**JVPL**", a listed entity), held by JAL ("**JPVL SPA**"); and
- (b) Business Transfer Agreement for acquisition of the 180 MW thermal power plant of JAL located in Churk and other related assets, including 11.49% shares of Prayagraj Power Generation Company Limited, held by JAL ("**BTA**").

This is to inform you that the aforesaid acquisitions by the Company have been consummated today in accordance with the terms of the JPVL SPA and the BTA, respectively, and as per the approved resolution plan in respect of JAL.
