Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations"), we wish to inform the Stock Exchange that certain Directors of the Company, have received an Ex-Parte Interim Order issued by the Securities and Exchange Board of India ("SEBI") vide Order No. **WTM/KM/IVD-1/ID-17/32480/2026-27**. Subsequent to the issuance of the aforesaid interim order, various media reports have referred to the name of **Osiajee Texfab Limited**, which has adversely affected the Company's goodwill and brand image amongst its stakeholders.

In this regard, the Company wishes to clarify that **Osiajee Texfab Limited is neither a noticee nor a party to the aforesaid interim order issued by SEBI**. The interim order has not been passed against the Company, and no directions or restrictions have been imposed upon the Company under the said order. The Company continues to conduct its business operations in the ordinary course, and there is no impact on its day-to-day operations or its obligations towards shareholders, customers, lenders, employees or any other stakeholders.

This clarification is being issued to ensure transparency and to prevent any misunderstanding arising from the media reports.
