Learned counsel for the petitioners seeks leave of this Court to withdraw this writ petition. An endorsement is also made to that effect.

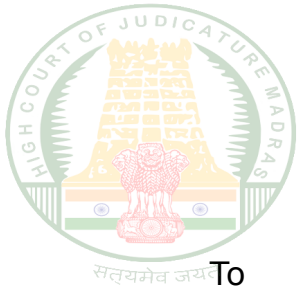
2. In view of the same, this writ petition stands dismissed as withdrawn. There shall be no order as to costs.
