Dear Sir/Ma'am,

Pursuant to Regulation 30 of Listing Regulations read with the SEBI Master Circular No. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30, 2026, we refer to our intimation dated June 07, 2026 wherein we informed you about the dispute between one Mr. Balaji Shivdas Pawar, Partner of Minakshi Agro Industries LLP ("MAILLP"), a subsidiary of the Company and MAILLP.

In this connection, we would like to inform you, MAILLP has on July 17, 2026 filed its Statement of Defence to the Statement of Claim filed by Mr. Balaji Pawar and has also filed its Counter Claim before the Sole Arbitrator. Further, MAILLP, in its Counter Claim has claimed an amount of Rs.34,85,97,745/- (Rupees Thirty Four Crore Eighty Five Lakh Ninety Seven Thousand Seven Hundred Forty Five Only). The Company is one of the Proforma Respondent in the Counter Claim filed by MAILLP.

The Statement of Defence and Counter Claim has been filed by MAILLP on July 17, 2026 at 4:16 p.m. (IST).
