O R D E R

SLP (C) No(s).33394-33395/2026 (It.23)

1. We have heard learned Senior Counsel for the petitioner at a considerable length. Learned counsel for the contesting respondents, who are on caveat, have also been heard.
2. We see no ground to interfere with the impugned judgment of the High Court. All that we find necessary to clarify is that the observations made by the High Court in various paragraphs, particularly paragraphs 201, 202, 213, 219, 220, 222, 223, 225, 227, 237, 241, 243, 244, and 252, are tentative and only for the purpose of making out a case for forensic audit.
3. It goes without saying that the forensic audit shall be conducted independently, without being influenced by the above-mentioned observations.
4. The Special Leave Petitions are, accordingly, dismissed.
5. Pending applications, if any, also stand disposed of.
