O R D E R

1. Issue notice to the respondents.
2. Rule is made returnable on 25.08.2026.
3. Mr. Sangramsingh R. Bhonsle, learned counsel, accepts notice on behalf of respondent No.1. Hence, the formal service of notice on the said respondent is waived.
4. In the meantime, the effect and operation of the impugned judgment/order dated 07.05.2026 in Writ Petition No.17274 of 2025 passed by the High Court of Bombay shall remain stayed.
5. Furthermore, it is directed that the recovery proceedings pursuant to the award dated 28.04.2025 rendered by the Industrial Tribunal at Thane in Reference (IT) No.11 of 2014 shall also remain stayed.
6. The petitioner/Vidyut Metallica Pvt. Ltd., to show its bona fides, shall deposit a sum of Rs.2,50,00,000/- (Rupees two crore fifty lakh only) in the Registry of this Court within a period of eight (08) weeks from today.
7. The amount so deposited shall initially be kept in a fixed deposit (duration : 06 months) with an auto-renewal option in any nationalized bank.
8. Let pleadings be completed in the meantime.
