Sub.: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

This is in furtherance to the disclosure made on 14th May, 2026 under Regulations 30(3), 30(4) read with Para B, Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 by Jagran Prakashan Limited ("JPL" / "Company").

The Company Appeals titled "Jagran Prakashan Limited v. Mahendra Mohan Gupta & Ors., C.A. No. 189 of 2026" and "Jagran Media Network Investment Private Limited v. Mahendra Mohan Gupta & Ors., C.A. No. 187 of 2026" were listed before the Hon'ble National Company Law Appellate Tribunal ("NCLAT") on 22nd May 2026. On the said date, both appeals were directed to be listed on 25th May 2026.

On 25th May 2026, C.A. No. 187 of 2026 came to be withdrawn. Extensive submissions were thereafter advanced by the parties in C.A. No. 189 of 2026. Upon hearing the parties, the Hon'ble Bench indicated that the matter would be listed on 26th May 2026 for further arguments.

Thereafter, on 26th May 2026, extensive arguments were again addressed on behalf of the parties. At the time of rising of the Court, the Hon'ble Bench indicated that orders in the matter would now be passed.
