UPON hearing the counsel the Court made the following
O R D E R

1. Issue notice, returnable on 17.08.2026.
2. Mr. Nitin Saluja, learned AOR accepts notice on behalf of the

respondent(s) on caveat and waives service of formal notice.

3. We are informed by the learned senior counsel appearing for the respondent no. 1 that one-third (33.33%) of the amount deposited before the High Court has already been withdrawn. We are of the opinion that atleast 50% of the total amount may be withdrawn by the respondent(s).

4. Pending disposal of the Special Leave Petition, the respondent is permitted to withdraw one-sixth (16.67%) of the total amount deposited before the High Court which would make it 50% of the total amount deposited. This withdrawal will be subject to providing security for the remaining one-sixth (16.67%) amount.

5. Let the written submission be filed by the parties in the meanwhile.
