O R D E R

C.A. No. 3124-3125/2026

Service is complete on Respondent Nos. 1, 5 to 10, 12, 17, 29 and 34 but no one has entered appearance.

Counter affidavit on behalf of Respondent Nos. 2 to 4 and 11, if any, be filed by 01.09.2026.

Notice sent to Respondent No.30 has not been delivered with remarks "Unclaimed". Therefore, service is deemed complete in terms of Judgement passed by this Hon'ble Court in K. Bhaskaran Vs.
