In terms of the requirements specified in the MCA Circulars, the Company is sending this Notice in electronic form only to those Members whose e-mail addresses are registered with the Registrar and Share Transfer Agent of the Company/Depositories/ Depository Participants. Accordingly, physical copy of the Notice along with Postal Ballot form and pre-paid business reply envelope is not being sent to the Members for this Postal Ballot. The communication of the assent or dissent of the Members would only take place through the remote e-voting system. The details of the procedure are mentioned in the notes.

In compliance with Regulation 44 of the SEBI Listing Regulations and pursuant to the provisions of Section 108 and Section 110 of the Act read with the Rules, the MCA Circulars and SS-2, the Company is providing remote e-voting facility to its Members, to enable them to cast their votes electronically instead of submitting the Postal Ballot form physically. The Company has engaged the services of Central Depository Services Limited (‘CDSL’) for the purpose of providing remote e- voting facility to its members. The instructions for remote e-voting are appended to this Notice. The Notice is also available on the website of the Company at www.rmcindia.in.

Members desirous of exercising their vote through the remote e-voting process are requested to carefully read the instructions indicated in this Notice and record their assent (FOR) or dissent (AGAINST) by following the procedure as stated in the Notes forming part of the Notice for casting of votes by remote e-voting from **Sunday, September 13, 2026 (9:00 A.M. “RESOLVED THAT pursuant to the provisions of Section 188(1)(b) and other applicable provisions, if any, of the Companies Act, 2013 (“Act”), read with Rule 15 of the Companies (Meetings of Board and its Powers) Rules, 2014, and in accordance with the applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and subject to such approvals, permissions and sanctions as may be required, consent and approval of the Members of the Company be and is hereby accorded to the Company for purchase/acquisition of the industrial land situated at Khasra No. 157, Gram-Barodiya, Gram Panchayat-Barodiya, Tehsil-Kotkhawada, Chaksu to Kotkhawada Road, District-Jaipur, Rajasthan-303901, owned by Mr. Ankit Agrawal, a Related Party of the Company, for a total consideration of ₹ 22,20,00,000/- (Rupees Twenty Two Crore Twenty Lakhs only), on such terms and conditions as may be mutually agreed between the Company and Mr. Ankit Agrawal.

The Explanatory Statement pursuant to the provisions of Section 102 of the Companies Act, 2013 (**'Act'**) read with Rule 22 of the Companies (Management and Administration) Rules, 2014 (**'Rules'**), each as amended, setting out the material facts relating to the aforesaid Resolution and the reasons therefore is annexed hereto and forms part of this Postal Ballot Notice (**'Notice'**).
2. In terms of the guidelines provided vide the MCA Circulars, the Company is sending this Notice in electronic form only to those Members whose names appear in the Register of Members/List of Beneficial Owners as received from the Depositories/ MUFG Intime India Pvt. Ltd(Formerly known as Link Intime India Private Limited),, the Company's Registrar and Transfer Agent (**'RTA'**) as on **Friday, September 4, 2026 ('Cut-Off Date')** and whose e-mail addresses are registered with the Company/ RTA/Depositories/Depository Participants (in case of electronic shareholding) or who will register their e-mail address in accordance with the process outlined in this Notice.
3. Members may also download the Notice from the Company's website at www.rmcindia.in or from CDSL's website at www.evoting.cdslindia.com. A copy of the Notice is also available on the website of BSE Limited at www.bseindia.com and National Stock Exchange of India Ltd. at www.nseindia.com.
4. Only those Members whose names are appearing in the Register of Members/List of Beneficial Owners as on the Cut-Off Date (September 4, 2026) shall be eligible to cast their votes through postal ballot.

It is also clarified that all Members of the Company as on the Cut-Off Date (including those Members who may not have received the Notice due to non-registration of their e-mail addresses with the Company/ RTA/ Depositories) shall be entitled to vote in relation to the aforementioned Resolution in accordance with the process specified in this Notice.

5. The Board of Directors has appointed CS Megha Khandelwal (FCS: 10237), Megha Khandelwal & Associates, Practicing Company Secretaries Jaipur as the Scrutinizer, through e-voting process, in a fair and transparent manner. The Scrutinizer's decision on the validity of the Postal Ballot shall be final.
6. As required by Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 read with the MCA Circulars and the Listing Regulations, the details pertaining to this Postal Ballot will be published in one English national daily newspaper circulating throughout India (in English language) and one Hindi daily newspaper circulating in Jaipur (in vernacular language i.e. Hindi).

7. In compliance with the provisions of Section 108 and Section 110 of the Act read with Rules 20 and 22 of the Rules, Regulation 44 of the SEBI Listing Regulations, SS-2 and the MCA Circulars, the Company is pleased to provide remote e-voting facility to its Members, to enable them to cast their votes electronically. The detailed procedure with respect to remote e-voting is mentioned in Note No. 14 of this Notice.
8. The remote e-voting shall commence on Sunday, September 13, 2026 (9:00 A.M. IST) and ends on Monday, October 12, 2026 (5:00 P.M. IST). During this period, the Members of the Company holding shares in physical or electronic form as on the Cut-Off Date Friday, September 4, 2026 may cast their votes electronically. The remote e-voting module shall be disabled by CDSL for voting immediately thereafter. Once the vote on a resolution is cast by the shareholder, the shareholder shall not be allowed to change it subsequently or cast vote again. The voting rights of the members shall be in proportion to their shares in the total paid-up equity share capital of the Company, as on the cut-off date i.e., Friday, September 4, 2026.
9. The Scrutinizer shall, within two working days from the conclusion of the e-voting process of Postal Ballot submit a consolidated scrutinizer report of the total votes cast in favour or against, if any, to the Chairman or a person authorized by him in writing, who shall counter sign on the same. 11. The vote in this Postal Ballot cannot be exercised through proxy. However, corporate and institutional members shall be entitled to vote through their authorised representatives with proof of their authorization. CDSL e-Voting System – For e-voting.

1. As you are aware, in view of the situation arising due to COVID-19 global pandemic, the general meetings of the companies shall be conducted as per the guidelines issued by the Ministry of Corporate Affairs (MCA) vide Circular No. 14/2020 dated April 8, 2020, Circular No.17/2020 dated April 13, 2020 and Circular No. 20/2020 dated May 05, 2020. The forthcoming AGM/EGM will thus be held through video conferencing (VC) or other audio visual means (OAVM). Hence, Members can attend and participate in the ensuing AGM/EGM through VC/OAVM.
2. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended), and MCA Circulars dated April 08, 2020, April 13, 2020 and May 05, 2020 the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the AGM/EGM. For the purpose, the Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) for facilitating voting through electronic means, as the authorized e-Voting's agency. The facility of casting votes by a member using remote e-voting as well as the e-voting system on the date of the EGM/AGM will be provided by CDSL.
3. The Members can join the EGM/AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the EGM/AGM through VC/OAVM will be made available to at least 1000 members on first come first served basis. There will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the EGM/AGM without restriction on account of first come first served basis.
4. The attendance of the Members attending the AGM/EGM through VC/OAVM will be counted for the purpose of ascertaining the quorum under Section 103 of the Companies Act, 2013.

5. Pursuant to MCA Circular No. 14/2020 dated April 08, 2020, the facility to appoint proxy to attend and cast vote for the members is not available for ther AGM/EGM. However, in pursuance of Section 112 and Section 113 of the Companies Act, 2013, representatives of the members such as the President of India or the Governor of a State or body corporate can attend the AGM/EGM through VC/OAVM and cast their votes through e-voting.
6. In line with the Ministry of Corporate Affairs (MCA) Circular No. 17/2020 dated April 13, 2020, the Notice calling the AGM/EGM has been uploaded on the website of the Company at www.rmcindia.in. The Notice can also be accessed from the websites of the Stock Exchanges i.e. BSE Limited and National Stock Exchange of India Limited at www.bseindia.com and www.nseindia.com respectively. The AGM/EGM Notice is also disseminated on the website of CDSL (agency for providing the Remote e-Voting facility and e-voting system during the AGM/EGM) i.e. www.evotingindia.com.
7. The AGM/EGM has been convened through VC/OAVM in compliance with applicable provisions of the Companies Act, 2013 read with MCA Circular No. 14/2020 dated April 8, 2020 and MCA Circular No. 17/2020 dated April 13, 2020 and MCA Circular No. 20/2020 dated May 05, 2020.
8. In continuation to ther Ministry's **General Circular No. 20/2020** dated 05.05.2020, General Circular No. 02/2022 dated 05.05.2022 and General Circular No. 10/2022 dated 28.12.2022 and after due examination, it has been decided to allow companies whose AGMs are due in the Year 2023 or 2024, to conduct their AGMs through VC or OAVM on or before 30th September, 2024 in accordance with the requirements laid down in Para 3 and Para 4 of the General Circular No. 20/2020 dated 05.05.2020.

THE INTRUCTIONS OF SHAREHOLDERS FOR E-VOTING ARE AS UNDER:

- Step 1** : Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.
- Step 2** : Access through CDSL e-Voting system in case of shareholders holding shares in physical mode and non-individual shareholders in demat mode.
- (i) The voting period begins on Sunday, September 13, 2026 (9:00 A.M. IST) and ends on Monday, October 12, 2026(5:00 P.M. IST). During the period shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date (04.09.2026) may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
 - (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.

- (iii) Pursuant to SEBI Circular No. **SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020**, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to **all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants**. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

Step 1 : Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.

- (iv) In terms of **SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020** on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

Explanatory Statement pursuant to Section 102 of the Companies Act, 2013

The following statement sets out the material facts concerning the special business mentioned in the accompanying notice to be transacted at the meeting.

Item No. [1]: Approval for purchase of industrial land from Mr. Ankit Agrawal, Related Party

The Company proposes to purchase/acquire an industrial land situated at Khasra No. 157, Gram-Barodiya, Gram Panchayat-Barodiya, Tehsil-Kotkhawada, Chaksu to Kotkhawada Road, District-Jaipur, Rajasthan-303901, along with the building/improvements thereon, owned by Mr. Ankit Agrawal, a Related Party of the Company, for a total consideration of ₹22,20,00,000/- (Rupees Twenty-Two Crore Twenty Lakh only).

The proposed transaction constitutes purchase of property of any kind from a Related Party and accordingly falls within the ambit of Section 188(1)(b) of the Companies Act, 2013, which covers buying property of any kind from a Related Party. The proposed transaction is also subject to such approvals as may be required under the applicable provisions of the Companies Act, 2013, the rules made thereunder and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Applicability of Regulation 23 of SEBI LODR Regulations:

The proposed transaction has also been evaluated under Regulation 23 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

As per Regulation 23(1), a related party transaction is considered a material related party transaction where the transaction(s), individually or taken together with previous transactions during a financial year, exceeds ₹1,000 crore or 10% of the annual consolidated turnover of the listed entity, whichever is lower.

The Company's annual consolidated turnover as per its latest audited financial statements for the financial year ended March 31, 2026, is ₹401.59 crore. Accordingly, 10% of the annual consolidated turnover amounts to ₹40.159 crore.

The value of the proposed transaction is ₹22,20,00,000/-, which, when considered individually and together with the previous related party transactions undertaken during the financial year, does not exceed the threshold of ₹40.159 crore, being 10% of the Company's annual consolidated turnover.

Accordingly, the proposed transaction does not qualify as a material related party transaction under Regulation 23(1) of the SEBI LODR Regulations and, therefore, the shareholder approval is not being sought under Regulation 23(4) of the SEBI LODR Regulations. The present approval of the Members is being sought pursuant to the applicable

provisions of Section 188 of the Companies Act, 2013, read with the applicable Rules thereunder.

The transaction is proposed to be undertaken on such terms and conditions as may be mutually agreed upon, taking into consideration the fair market value/valuation of the property and other relevant commercial considerations.

The fair market value of the property is ₹22,42,32,000/- (Rupees Twenty-Two Crore Forty-Two Lakh Thirty-Two Thousand only), whereas the Company proposes to purchase the property for ₹22,20,00,000/- (Rupees Twenty-Two Crore Twenty Lakh only). Accordingly, the proposed purchase consideration is ₹22,20,00,000/- lower than the fair market value of the property. The acquisition is therefore proposed to be undertaken at a consideration below the assessed fair market value.

The proposed acquisition also has a direct operational and economic rationale for the Company and its subsidiary. The said land and building are presently being used by the Company's subsidiary, RMC Green Energy Private Limited, for its business operations. The subsidiary is presently paying ₹3,00,000/- per month, aggregating to approximately ₹36,00,000/- per annum, towards rent/usage charges for use of the said land and building.

Upon acquisition of the property by the Company, the Company/Group would obtain ownership and long-term control over the premises presently being used by RMC Green Energy Private Limited. The acquisition is expected to reduce/eliminate the recurring rental/usage expenditure of ₹3,00,000/- per month presently being incurred by the subsidiary, thereby resulting in recurring cost savings for the subsidiary and the Group. It will also provide greater certainty and stability in respect of the premises required for the subsidiary's business operations.

The proposed transaction has accordingly been evaluated by the Audit Committee and the Board of Directors by considering, inter alia, the fair market value of the property, proposed purchase consideration, existing use of the property by the Company's subsidiary, recurring rental/usage expenditure and the long-term commercial and operational benefits arising from ownership of the property.

Based on the above considerations, the Audit Committee has recommended the proposed transaction to the Board of Directors. The Board of Directors is of the opinion that the proposed acquisition is fair, reasonable and in the best interests of the Company and its stakeholders, particularly considering that the proposed consideration is below the fair market value and the acquisition is expected to result in recurring savings in rental/usage expenditure presently incurred by the Company's subsidiary.
