Pursuant to Regulation 30 read with Para B of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), we wish to inform you that the Company has commenced commercial production of Phase-1 at its newly established manufacturing facility located at Kheda, Gujarat with effect from 9th July'2026

The commencement of commercial production marks a significant milestone in the Company's expansion plans. The commissioning of the facility has resulted in an enhancement of the Company's manufacturing capacity.

Consequent to the above capacity addition, the Company's total installed manufacturing capacity has increased from **201,000 MT to 221,000 MT** with effect from 9th July'2026
