**3. Dividend & Record Date:** The Board of Directors at its meeting held on April 23, 2026, has recommended a Final Dividend of INR 53/- per equity share of face value of INR 1/- each for approval of the Members. Accordingly, the final dividend for FY-26, if approved by Members at the 30<sup>th</sup> AGM, shall be paid after deducting tax at source ('TDS') in accordance with the provisions of the Income Tax Act, 2025.

# मुंबबाडमधील अपघातात अहिल्यानगरच्या चौघांचा मृत्यू

**बदलापूर :** कल्याण-अहिल्यानगर राष्ट्रीय महामार्गावर अपघाताची मालिका सुरू असून मंगळवारी सकाळी साडेदहाच्या सुमारास मुंबबाड तालुक्यातील टोकावडे पोलीस ठाण्याच्या हद्दीत वैशाखरे फाट्याजवळ राज्य परिवहन मंडळाची बस आणि स्कॉर्पिओ गाडीचा भीषण अपघात झाला. या दुर्घटनेत स्कॉर्पिओ गाडीतून प्रवास करणाऱ्या एकाच कुटुंबातील चौघांचा जागीच मृत्यू झाला असून अन्य चार जण गंभीर जखमी झाले आहेत.

अहिल्यानगर जिल्ह्यातील नेवासा येथील हे कुटुंब मुंबईच्या दिशेने जात असताना वैशाखरे फाट्याजवळ समोरून येणाऱ्या एसटी बसशी त्यांच्या वाहनाची जोरदार धडक झाली. या अपघातात अविनाश रामचंद्र काकडे, अभिषेक भाऊसाहेब मोटे (दोघे रा. वडाळा, ता. नेवासा), नीता अशोक धुरे आणि मीना कल्याण मडके (दोघी रा. भेंडा, ता. नेवासा) यांचा जागीच मृत्यू झाला. तर मोनिका अभिषेक मोटे, आराध्या अभिषेक मोटे, वैदांश अभिषेक मोटे आणि मनीषा रामदास बहक हे गंभीर जखमी झाले आहेत. त्यांना तातडीने उपचारांसाठी कल्याण येथील



रुग्णालयात दाखल करण्यात आले आहे, अशी माहिती तहसीलदार अभिजित देशमुख यांनी दिली. कल्याण-अहिल्यानगर राष्ट्रीय महामार्गाच्या रुंदीकरण आणि काँक्रीटकरणामुळे वाहनांचा वेग वाढला आहे. मात्र बेशिस्त आणि बेदरकार वाहन चालकांमुळे अपघातांचे प्रमाणही वाढले आहेत. गेल्याच महिन्यात १३ एप्रिल रोजी रायते पुलावर झालेल्या अपघातात ११ जणांना प्राण गमवावे लागले होते. त्या घटनेला महिना उलटत नाही तोच आज पुन्हा चौघांचा बळी गेल्याने प्रवाशांच्या सुरक्षिततेचा प्रश्न ऐरणेवर आला आहे. हा अपघात कशामुळे झाला, नेमकी चूक कुणाची हे मात्र स्पष्ट होऊ शकले नाही. घटनेची माहिती मिळताच टोकावडे पोलीस आणि स्थानिक नागरिकांनी मदतीसाठी धाव घेतली. अपघातामुळे महामार्गावरील वाहतूक काही काळ विस्कळीत झाली होती.

असेही न्यायालयाने स्पष्ट केले. ट्रस्टचे संस्थापक किशोर मेहता यांचा २०२४ मध्ये बँकेने निर्माण केलेल्या दबावामुळे मृत्यू झाला, हा ट्रस्टचा दावाही फेटाळताना न्यायालयाने या घटनेसाठी बँकेच्या अधिकाऱ्यांना जबाबदार धरता येणार नाही, असे स्पष्ट केले. माजी व विद्यमान विश्वस्तांमधील कटुता, अविश्वास व ताणलेल्या संबंधांचे परिणाम बँकेच्या अधिकाऱ्याला भोगावे लागत असल्याचेही न्यायालयाने अधोरेखित केले.
