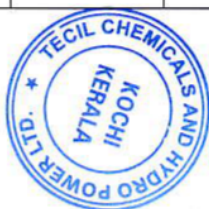

2. Dispatch of Notice convening the Meeting

The Notice dated 12th August, 2026 along with the statement stating out material facts under Section 102 of the Act were completely sent to the shareholders by Tuesday 1st September 2026, in respect of the below mentioned resolutions proposed at an Annual General Meeting of the Company.

3. Cut-off Date

The Remote E-Voting period has begun on 21st September, 2026 at 09:00 A.M. and has ended on 23rd September, 2026 at 05:00 P.M. During this period Shareholders of the Company, holding shares either in physical form or in dematerialized form, as on the cut-



off date (book closure date) of 17th September 2026, has cast their vote electronically. The Remote E-Voting module has been disabled by CDSL for voting thereafter.

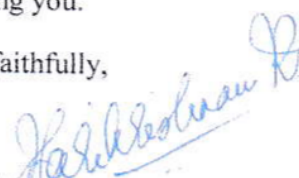
