UPON hearing the counsel the Court made the following
O R D E R

1. In pursuance of our order passed yesterday, dated 22nd September, 2026, the respondent no.1, Yudh Chand Bains, has filed an affidavit-cum-undertaking, stating as under:-

AFFIDAVIT-CUM-UNDERTAKING

I, Yudh Chand Bains, son of Puran Chand, aged about 53 years, resident of Village Bhura, PO Rajgarh, Tehsil, Sadar, District, Mandi, Himachal Pradesh, presently at New Delhi:-

1. That I am Respondent No.1 in the above-mentioned Special Leave Petition, and as such, I am well acquainted with the facts and circumstances of the case.

2. That the present Affidavit-Cum-Undertaking is being filed, for the purpose of placing on record an undertaking on oath, in compliance with the directions issued by this Hon'ble Court vide its order dated 22.09.2026.

3. I hereby undertake to pay the entire outstanding loan liability of Rs. 74.54 Crore (Rupees Seventy Four Crores and Fifty Four Lacs) as on 25.08.2026, together with the future interest accruing thereon, to the Kangra Central Co-operative Bank in respect of the loan accounts of M/s Hotel Lake Palace and M/s Himalayan Snow Village, within a period of five months commencing from 23.09.2026, that is to say, on or before 22.02.2027.

4. That I am not a holder of an Indian passport, and no passport has at any time been issued to me by any competent authority.

5. That I shall remain available to the investigating agency/judicial process and shall duly co-operate with the same in connection with investigation/proceedings arising from FIR 02 of 2025 dated 08.01.2025 registered at PS State Vigilance and Anti-corruption Bureau, Una.

6. That I am conscious that the undertaking recorded hereinabove is given to this Hon'ble Court, and that any breach or violation thereof shall render me liable to be proceeded against for contempt of this Hon'ble Court, apart from such other consequences as this Hon'ble Court may deem appropriate.

7. That the present affidavit-cum-undertaking is being filed bona fide and in the interest of justice.

DEPONENT"

2. The notarized affidavit-cum-undertaking is ordered to be taken on record and the same shall be kept with the record of this case.

3. The respondent no.1-deponent shall abide by what he has stated in the affidavit-cum-undertaking on oath.

4. We make it clear that the payment, as undertaken by the respondent no.1 shall be directly made to his loan account by RTGS. The Bank shall not accept any cheque that may be issued by the respondent no.1.

5. *Status quo*, as regards the two sites/ properties, one at Mandi, Himachal Pradesh and another at Manali, Himachal Pradesh, shall be maintained and both these sites/ properties shall remain under the supervision of the Bank.

6. Post the Special Leave Petitions for further hearing on 23rd February, 2027 at 03:30 P.M. before this same Bench. The matter to be treated as part-heard.
