Particulars	Details
The details of any change in the status and / or any development in relation to such proceedings;	1. AFCON's raised a dispute in the matter of work package T-74R-A, amounting to ₹ 359.72 Cr. on 22.02.2023, and the same is already reported vide letter no. IRCON /SECY/STEX/124 dt. 14.08.2023. 2. Majority Tribunal declared an award of ₹ 147,14,48,522/- on 29.06. 2026, against the claim value of ₹359.72 Cr. 3. Today, i.e. on 23/09/2026, Minority Tribunal declared dissent opinion by awarding ₹ 23,64,20,885/- against the claim value of ₹359.72 Cr. 4. The arbitration process is now completed. 5. However, IRCON will be challenging the award before the High Court of Delhi in accordance with the law.
