Dear Sir/Madam,

Pursuant to Regulation 29(2) of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, we wish to inform you that the Company has received separate disclosures, both dated 24th June, 2026, from Dr. Bhaskara Rao Bollineni (Transferor/Donor) and Mr. Bhavanam Ruthvik Reddy (Transferee/Donee), Promoters of the Company, in respect of an inter-se transfer of equity shares within the Promoter Group.

As per the disclosures received, Dr. Bhaskara Rao Bollineni has transferred 3,00,000 (Three Lakhs) equity shares, representing 1.76% of the paid-up equity share capital of the Company, to Mr. Bhavanam Ruthvik Reddy through an off-market transaction by way of gift on 24th June, 2026.


