O R D E R

Issue notice in I.A. No. 234896/2026.

Notice shall be served by all modes, including *dasti*.

In the light of the notice dated on 30.08.2023 issued by the Piramal Capital and Housing Finance Ltd. (earlier known as DHFL), under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002, wherein details have been furnished of the mortgaged Villas, which according to the learned senior counsel for the petitioner were the subject matter of the Memorandum of Understanding¹ dated 06.03.2014, we would require clarity as to how these Villas were

booked or sold, in terms of the allotment letters therefor being issued either unilaterally or jointly by the owner and the developer.

Copies of the allotment letters in relation to the Villas in question, covered by the aforestated MoU, shall be produced by way of separate applications.

Both parties are at liberty to file the allotment letters which may be in their possession.

Learned counsel appearing for the State of Rajasthan shall furnish full details of the cases in which the petitioner has either been granted bail or interim protection from arrest.
