In continuation thereof, we wish to inform you that the Company has received on July 09, 2026, **Conditional Revocation Directions letter dated July 07, 2026**, from the **Central Pollution Control Board (CPCB)** under Section 5 of the Environment (Protection) Act, 1986, whereby the closure directions vide letter dated **January 29, 2026**, have been **conditionally revoked**. The necessary steps are being undertaken to ensure smooth resumption of operations in compliance with all applicable statutory and regulatory requirements.

Pursuant to Regulation 30 of the Listing Regulations read with SEBI Circular SEBI/HO/CFD/CFDPoD-1/P/CIR/2023/123 dated July 13, 2023, and SEBI/HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30, 2026, the requisite disclosure is set out in **Annexure A** to this letter.

Simbhaoli Sugars Limited is currently undergoing Corporate Insolvency Resolution Process pursuant to the provisions of the Insolvency and Bankruptcy Code, 2016 w.e.f. 11th July, 2024. Since, the powers of Board of Directors stands suspended pursuant to the initiation of CIR Process, vide order dated 11th July, 2024, the adjudicating authority appointed Mr. Anurag Goel (IBBI/PA-001/IP-P-00876/2017-18/11460), Interim Resolution Professional (IRP) who is managing assets, management and carrying the functions mentioned under the Insolvency Bankruptcy Code.
