O R D E R

1. Heard Mr. Ravi Prakash, learned Senior Counsel for the petitioner(s) and Mr. B. H. Marlapalle, learned Senior Counsel for the respondent(s).
2. As ordered by 27.01.2026 of the amount deposited, the
