Heard learned senior counsel/counsel for the parties.

2. The present application has been filed seeking clarification of the order dated 21.05.2025 passed by this Court in Civil Appeal No.7057 of 2025.

3. Learned senior counsel for the applicants-petitioners submits that in the said order at paragraph no.7, though it has been noted

that a sum of Rs.41,21,664/- (Rupees Forty One Lakhs Twenty One Thousand Six Hundred Sixty Four) along with the interest of 8% per annum was to be paid by the respondent no.2 to the appellants/applicants, it has further been noted that the same be done within a period of two months from that day, "after adjusting what may already have been paid." It was submitted that as on that day, both the parties had worked out a calculation, the aforesaid amount was over and above what had already been paid by that day and thus, the present observation that "after adjusting what may already have been paid" has created a confusion, which the Court may clarify/remove.

4. Learned counsel for the respondent no.2-Insurance Company does not dispute the said position.

5. Accordingly, the words "after adjusting what may already have been paid" in paragraph no.7 of the order dated 21.05.2025, stand deleted. Rest of the order remains the same.

6. Accordingly, the Interlocutory Application No.147668 of 2025 stands allowed in the aforementioned terms.

7. Consequently, the Miscellaneous Application stands disposed of.
