**UPON hearing the counsel the Court made the following
O R D E R**

- 1.** Permission to file special leave petition(s) is granted.
- 2.** The SLP(s) has been filed against an Interim Order dated 09.07.2026 passed by the High Court, whereunder the effect and operation of the Order dated 01.07.2026 and 29.06.2026 has been stayed.
- 3.** It is also clarified by the learned Division Bench under the aforesaid impugned order that the stay shall operate only *qua* that part of the Order which restrains/restricts the appellant from conducting counselling. A further observation has been made that the learned Single Judge of the Court shall continue to adjudicate the remaining aspects of the matter.
- 4.** Petitioner herein who is not a party in the Writ Appeal has sought leave of the Court to challenge the said Interim Order passed by the Division Bench dated 09.07.2026 by the this petition. Since, the issue is still at large and appeal is pending before the Division Bench we grant liberty to the petitioner to approach the Division Bench for appropriate reliefs, if so advised.

5. With this observation, the special leave petitions stand dismissed.
