In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform you that NTPC-SAIL Power Company Limited (NSPCL), a joint venture company of NTPC Limited, vide its e-mail dated 30th June 2026, has intimated the Company that the third and final module (Island-2) of 5 MW (2 X 2.5 MW) of NSPCL Bhilai Floating Solar Power Station has been successfully commissioned on 24th June 2026. Accordingly, the entire 15 MW Floating Solar Power Station has been declared under commercial operation with effect from 24th June 2026.

With this, the total installed capacity of NTPC group stands at 90,904 MW and commercial capacity at 89,824 MW.
