Kindly refer to our above referred letter dated 20.02.2026 informing that Ministry of Railways (MOR) vide its order no. 2021/E(O)II/40/29, dated 20.02.2026, has communicated that the Ministry has decided that, pending approval of the Competent Authority, the additional charge of the post of Director (Domestic Division), Container Corporation of India Ltd. (CONCOR) may be entrusted to Shri H.S. Bajwa, IRTS, ED(FM), Railway Board in addition to his own, with effect from the date of assumption of charge of the post on or after 01.03.2026 and until further orders. Vide letter dated 01.03.2026 it was informed that Shri Harbrinder Singh Bajwa (DIN: 11506675) assumed the additional charge of Director (Domestic Division) of CONCOR w.e.f 01.03.2026(FN). Further, vide letter dated 06.03.2026, it was informed that Board of Directors in its meeting on 06.03.2026, has appointed Shri Harbrinder Singh Bajwa (DIN: 11506675), as Director (Domestic Division) (additional charge) of CONCOR w.e.f. 01.03.2026.

Now, vide order no. 2021/E(O)II/40/29, it has been informed by Ministry of Railways that the Competent Authority has, ex-post facto, approved entrustment of the additional charge of the post of Director (Domestic Division), Container Corporation of India Ltd. (CONCOR) to Shri H. S. Bajwa, IRTS, ED(FM), Railway Board, in addition to his own, for a period of 09 months w.e.f. 01.03.26 or till assumption of charge of the post by the regular incumbent or until further orders, whichever is the earliest.
