With reference to above, we would like to submit as under:

- (1) Our Company is primarily involved in manufacturing of Electrical Transformers, CRGO, electrical accessories and other related items and is also involved in execution of EPC Contracts involving Electrical Items. The Company's registered office is at C-61, C-61(A&B), Road No. 1C, VKI Area, Jaipur, Rajasthan, India, 302013 and its manufacturing units are located at Jaipur, Reengus (Sikar) & Pratapgarh Rajasthan.
- (2) As per our accounting policy No XXIII disclosed in Annual Financial Statements for the year ended March 31, 2025 ***“Segment Reporting - Operating segments are those components of the business whose operating results are regularly reviewed by the chief operating decision making body in the Company to make decisions for performance assessment and resource allocation. The company is primarily involved in manufacturing and trading of Electrical Transformers, CRGO, Electrical Accessories and other related items and is also involved in execution of EPC contracts involving Electrical Items. The main business of the Company is of manufacturing and sales of Electrical Transformers, CRGO and other electrical accessories. All other activities of the Company revolve around the main business and the chief operating decision making body in the company reviews the same as only one segment i.e. related to power. Therefore, there is only one reportable segment. Further, there are no reportable geographic segments.”***
- (3) Further in accordance with the Para 11 of Ind AS 108 **“Reportable Segments - An entity shall report separately information about each operating segment that:**
 - (a) has been identified in accordance with paragraphs 5–10 or results from aggregating two or more of those segments in accordance with paragraph 12, and
 - (b) exceeds the quantitative thresholds in paragraph 13.

- (4) The prescribed threshold limit as per Ind AS 108 for identification of reportable segments with respect to various work streams of the company was not getting exceeded for the year ended March 31, 2025 and the *Chief operating decision making body in the company also reviews the same as only one segment i.e. related to power. Therefore, there is only one reportable segment. Further, there are no reportable geographic segments.*”
- (5) Accordingly, for the quarter ended June 30, 2025, the Company had concluded that it had only one reportable segment in accordance with the requirements of Ind AS 108. Therefore, separate segment information was not disclosed in the unaudited financial results for the said quarter.
