DIRECTORS' REPORT

To the Members,

Your Directors are pleased to present the 77th Annual Report of The Phosphate Company Limited, together with the Audited Financial Statements for the financial year ended 31st March, 2026.

Financial Highlights

Business Performance and Operations

FY 2025-26 marked another year of resilient growth for your Company. Despite significant volatility in raw material markets, particularly Sulphuric Acid and Spent Acid, the Company delivered improved operational and financial performance through disciplined procurement, efficient manufacturing, prudent inventory management and sustained market demand. Favourable monsoon conditions, higher subsidy support and improved market realisation further strengthened the Company's performance during the year.

Production & Sales

- Production of Green Single Super Phosphate (SSP) fertiliser was 75,890 MT, an increase of around 3% on a YoY basis.
- Sales of SSP (powder and granulated combined) were 77,458 MT, a growth of more than 6% compared with the previous year.

Subsidy

- Under the Nutrient-Based Subsidy (NBS) Policy, the Government of India has announced a subsidy of ₹8,149 per MT for SSP fertiliser for H1 of FY 2026-27, payable on sales made to farmers through Point-of-Sale (PoS) machines.
- Fertiliser subsidy was disbursed at ₹7,263 per MT during H1 of FY 2025-26, revised upward to ₹7,408 per MT for H2 of FY 2025-26.

New Products

As part of its strategic product diversification initiative, the Company expanded its range of Specialty Nutrient, Crop Protection Chemicals and Seeds under the SAMADHAN brand. The encouraging market response reinforces management's confidence in expanding this portfolio as an important driver of future growth. Simultaneously, the Company strengthened its product basket by marketing imported Di-Ammonium Phosphate (DAP), enhancing its ability to serve farmers through a broader range of crop nutrition solutions.

Outlook

Raw material prices are a key concern due to geopolitical tension and disruption to maritime trade routes. Looking ahead, the Company plans to:

- Expand the SAMADHAN brand by introducing additional varieties of paddy and other seeds, and widen the SNPC portfolio.
- Strengthen brand equity and the distribution network to capture incremental demand opportunities in the agri-input market.

Your Directors are confident that these initiatives will enable sustainable growth and improved financial performance in the coming years.

Dividend

Your Directors are pleased to recommend, for the approval of the Members at the ensuing Annual General Meeting, a dividend of 20%, i.e., Rs. 2.00 per equity share of Rs. 10/- each, on 36,07,480 equity shares for the financial year ended 31st March, 2026. The total dividend pay-out amounts to Rs. 72.15 lakh. The dividend, if approved, will be paid to those Members whose names appear in the Register of Members (or in the records of the depositories as beneficial owners) as on the Record Date, i.e., 16th September, 2026.

Transfer to General Reserves

No amount is proposed to be transferred to General Reserves.

Public Deposits

The Company has neither accepted nor holds any deposits under Section 73 of the Companies Act, 2013, as on 31st March 2026.

Risk Management

Pursuant to Section 134(3)(n) of the Companies Act, 2013, the Company has in place a comprehensive risk management framework to identify, evaluate, monitor and mitigate various business risks. Risks across different functions and departments are periodically reviewed, and appropriate mitigation measures are implemented to minimise their potential impact.

Based on the assessment carried out during the year under review, no risk has been identified that, in the opinion of the Board, may threaten the existence of the Company or materially affect its operations in the agro-input business.

The Company's Internal Audit function, in coordination with the respective departmental heads, periodically evaluates key business and operational risks and reviews the adequacy and effectiveness of the internal control systems. Observations and recommendations arising from such reviews are placed before the Audit Committee, which monitors implementation of corrective actions and the strengthening of internal control processes.

Statutory Auditors

M/s S.K. Agrawal and Co., Chartered Accountants LLP (Firm Registration No. 306033E/E300272), continue to hold office as Statutory Auditors of the Company until the conclusion of the 79th Annual General Meeting to be held in 2027, in accordance with the Companies Act, 2013.

The Statutory Auditors have audited the financial statements of the Company for the financial year ended 31st March 2026. The Auditors' Report on the standalone financial statements does not contain any qualification, reservation, adverse remark or disclaimer, and is self-explanatory. Accordingly, no further explanation from the Board is required under Section 134(3)(f) of the Companies Act, 2013.

Cost Audit

Pursuant to Section 148 of the Companies Act, 2013, read with the Companies (Audit and Auditors) Rules, 2014, the Board of Directors, on the recommendation of the Audit Committee, has appointed M/s S. Gupta & Co., Cost Accountants (Firm Registration No. 000020), as Cost Auditors of the Company to conduct the audit of cost records for FY 2026-27, at a remuneration to be ratified by the Members at the ensuing Annual General Meeting.

Further, the Department of Fertilisers, Government of India, has directed the Company to undertake a Special Audit of Cost Data for FY 2026-27 under the Nutrient Based Subsidy (NBS) Policy, to examine the reasonableness of the Maximum Retail Price (MRP) of fertilisers. This Special Audit will also be conducted by M/s S. Gupta & Co., Cost Accountants.

Internal Audit

M/s Batliboi Purohit & Darbari, Chartered Accountants (FRN: 303086E), continue to serve as Internal Auditors for FY 2026–27.

Secretarial Audit

Pursuant to Section 204 of the Companies Act, 2013, read with the Companies (Appointment and Remuneration of Managerial Personnel) Rules, 2014, the Board of Directors has re-appointed CS Ajay Kumar Agarwal, Proprietor of M/s Agarwal A & Associates, Practising Company Secretaries (Certificate of Practice No. 13493, FCS No. 7604), as Secretarial Auditor of the Company for a term of five consecutive financial years commencing FY 2025–26, in accordance with the Companies Act, 2013 and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The Secretarial Audit Report for the financial year ended 31st March 2026, in Form MR-3, is annexed to this Report as Annexure I. The report does not contain any qualification, reservation, adverse remark or disclaimer requiring explanation from the Board.

The Company has complied with the applicable Secretarial Standards, namely SS-1 (Meetings of the Board of Directors) and SS-2 (General Meetings), issued by the Institute of Company Secretaries of India and approved by the Central Government.

Re-appointment of Director Retiring by Rotation

In accordance with Section 152 of the Companies Act, 2013, and the Articles of Association of the Company, Sri Ajay Bangur (DIN: 00041711) retires by rotation at the ensuing Annual General Meeting and, being eligible, has offered himself for re-appointment.

The Board places on record its appreciation for the valuable guidance, leadership and significant contributions made by Sri Ajay Bangur during his tenure as Executive Director of the Company. In view of his extensive experience, expertise and continued contribution to the growth and affairs of the Company, the Board recommends his re-appointment to the Members for approval.

A brief profile of Sri Ajay Bangur, along with other disclosures required under the Companies Act, 2013 and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, is provided in the Notice convening the ensuing Annual General Meeting.

Continuation of Independent Director in Terms of Corporate Governance Provision

Pursuant to Regulation 25(2A) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, applicable to the Company with effect from 30th September 2026, the appointment or re-appointment of an Independent Director requires approval of the Members by way of a Special Resolution.

Sri Gautam Bhattacharya (DIN: 10834784) was appointed as an Independent Director of the Company by the Members through an Ordinary Resolution passed at the Annual General Meeting held on 23rd September 2025. To ensure continued compliance with the aforesaid Regulation and applicable provisions of the Companies Act, 2013, the approval of the Members is being sought by way of a Special Resolution at the ensuing Annual General Meeting for his re-appointment. Considering his profile, the Directors recommend his re-appointment.

A brief profile of Sri Gautam Bhattacharya, together with the disclosures required under the Companies Act, 2013 and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, is set out in the Notice convening the ensuing Annual General Meeting.

Independent Directors' Declaration

The Company has received the necessary declarations from all Independent Directors confirming that they meet the criteria of independence prescribed under Section 149(6), and have submitted declarations pursuant to Section 149(7) of the Companies Act, 2013. The Independent Directors have also confirmed compliance with Regulation 16(1)(b) and Regulation 25(8) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The Board of Directors has taken the said declarations on record and is satisfied that all Independent Directors continue to fulfil the criteria of independence prescribed under the Companies Act, 2013, and the SEBI Listing Regulations. The Board further confirms there has been no change in the circumstances affecting their status as Independent Directors during the year under review.

The Company has also ensured that the names of all Independent Directors are included in the databank maintained by the Indian Institute of Corporate Affairs (IICA), in compliance with the Companies Act, 2013 and the Companies (Appointment and Qualification of Directors) Rules, 2014.

Board Meetings

During FY 2025-26, the Board met four times, on the following dates:

The interval between meetings was within the limits prescribed by the Companies Act, 2013 and SEBI Regulations.

Share Capital & Reconciliation

There has been no change in the capital structure of the Company during the year under review. The Equity Share Capital of the Company is Rs. 3,60,74,800 divided into 36,07,480 Equity Shares of Rs. 10/- each, as at the close of FY 2025-26.

As stipulated by the Securities and Exchange Board of India (SEBI), a Reconciliation of Share Capital Audit is carried out every quarter. The Report is placed before the Board of Directors and submitted to the Stock Exchanges.

Dematerialisation of Shares

Pursuant to the SEBI (Listing Obligations and Disclosure Requirements) (Fourth Amendment) Regulations, 2018, effective 1st April 2019, transfers of securities in physical form are no longer permitted; all transfers must be in dematerialised form.

The Company's shares are available for dematerialisation with both major depositories in India:

As on 31st March 2026, approximately 95.95% of the total equity share capital stands dematerialised.

Prevention of Insider Trading

The Company's Code of Conduct for Prevention of Insider Trading, originally adopted in 2015, continues to be in force. It prohibits directors and employees from trading in the Company's securities while in possession of unpublished price-sensitive information.

The Company also maintains a tamper-proof structured digital database with an audit trail to record all communications of such sensitive information shared for legitimate purposes, in compliance with SEBI's requirements.

Industry Review

India is the world's second-largest consumer of fertilisers and, despite being heavily import-dependent for raw materials, has emerged as the third-largest producer globally. The consumption of complex fertilisers continues to increase, largely at the expense of straight fertilisers, primarily due to labour shortages.

During FY2025-26, Single Super Phosphate(SSP) accounted for only 17.2% of total P_2O_5 production.

According to 2023 data published by FAI, India ranks second in global SSP consumption, following Brazil.

Government Policy

The Government of India has introduced PM-PRANAM, an integrated nutrient management scheme to encourage balanced fertiliser use. Further, for Kharif 2026, the Government has announced a subsidy of ₹8,149 per MT on the sale of SSP fertiliser to farmers through the Point-of-Sale (PoS) system.

Review of the Company

The LAKSHMI brand continues to be a trusted choice among farmers. In addition, the Company has expanded its product portfolio by launching Speciality Nutrient & Crop Protection Chemicals (SNPC) under the SAMADHAN brand, which is being well received in the market.

Opportunities and Risks

Opportunities

With its strong brand equity and established distribution network, the Company is well positioned to capture market share in new product categories. The recently launched SAMADHAN range is expected to gain positive traction among farmers.

Risks

The global fertiliser raw material supply chain remains under stress due to ongoing geopolitical conflicts, including the Russia–Ukraine war and tensions in the Middle East (USA, Israel–Iran). This could disrupt availability and impact costs.

Internal Control Systems and Adequacy

The Company maintains a robust internal control system, commensurate with the size and complexity of its operations. These controls ensure the safeguarding of assets against unauthorised use or loss, and that all transactions are properly authorised, recorded and reported in accordance with generally accepted accounting principles. The Internal Auditor periodically reviews these systems to ensure continued adequacy and effectiveness.

The Financial Statements have been prepared as per IND-AS, in conformity with applicable accounting standards, with proper explanations justifying the cause of any deviation wherever it occurred. The Notes to the Financial Statements, read with the Auditors' Reports on financial statements, give the necessary disclosure of all relevant accounting treatments appended with the Directors' Report.

In case of appointment of Independent Directors, the Committee shall satisfy itself with regard to the degree of independence of the Directors in relation to the Company so as to enable the Board to discharge its function and duties effectively. The Committee shall ensure that the candidate identified for appointment as a Director is not disqualified for appointment under Section 164 of the Companies Act, 2013. The Committee shall consider the following attributes / criteria, whilst recommending to the Board the candidature for appointment as Director.

- i. Qualification, expertise and experience of the Directors in their respective fields;
- ii. Personal, Professional or business standing;
- iii. Diversity of the Board.

In case of re-appointment of Non-Executive Directors, the Board shall take into consideration the performance evaluation of the Director and his engagement level.

Remuneration

The Non-Executive Directors shall be entitled to receive remuneration by way of sitting fees, and reimbursement of expenses for participation in the Board and Committee meetings. A Non-Executive Director shall be entitled to receive sitting fees for each meeting of the Board and Committees attended by him, of such sum as may be approved by the Board of Directors within the overall limits prescribed under the Companies Act, 2013 and The Companies (Appointment and Remuneration of Managerial Personnel) Rules, 2014;

CEO& Managing Director - Criteria for selection / appointment

For the purpose of selection of the CEO& MD, the Committee shall identify persons of integrity who possess relevant expertise, experience and leadership qualities required for the position and shall take into consideration recommendation, if any, received from any member of the Board. The Committee will also ensure that the prospective incumbent fulfils such other criteria with regard to age and other qualifications as laid down under the Companies Act, 2013 or other applicable laws.

Remuneration for the CEO& Managing Director

At the time of appointment or re-appointment, the CEO& Managing Director shall be paid such remuneration as may be mutually agreed between the Company (the Committee and the Board of Directors) and the CEO& Managing Director within the overall limits prescribed under the Companies Act, 2013. The remuneration shall be subject to the approval/ratification of the Members of the Company in General Meeting. The remuneration of the CEO& Managing Director comprises only of fixed component. The fixed component comprises salary, allowances, perquisites, amenities and retirement benefits.

Remuneration Policy for the Senior Management Employees

In determining the remuneration of the Senior Management Employees (i.e. KMPs and Executive Committee Members) the Committee shall ensure the relationship of remuneration and performance benchmark is clear. The Executive Director will carry out the individual performance review based on the standard appraisal matrix and shall take into account the appraisal score card and other factors mentioned herein-above, whilst recommending the annual increment and performance incentive to the Committee for its review and approval.

Notes to Financial Statements as at and for the year ended March 31,2026

1. Company Overview

The Phosphate Company Limited ("the Company") is a limited company incorporated in India, having its registered office situated at 14, Netaji Subhas Road, Kolkata. The Company has its shares listed on Calcutta Stock Exchange Limited (CSE) and BSE Limited (BSE). The Company is primarily engaged in manufacturing and trading of farm inputs comprising of fertiliser, crop protection, specialty nutrients, acids and organic compost. The manufacturing unit of the company is located at Rishra, West Bengal.

2. Material Accounting Policies

a) Basis of Preparation

These accounts have been prepared in accordance with Indian Accounting Standards (Ind AS) prescribed under Section 133 of the Companies Act 2013 ("Act") read with relevant Rules. These financial statements are prepared in accordance with historical cost convention on the accrual basis except for certain financial instruments which are measured at fair values.

b) Revenue from Contract with Customer

Revenue is measured at the fair value of the consideration received or receivable, net of returns, discounts, volume rebates, outgoing sales taxes and goods and service tax. The Company recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the Company regardless of when the payment is being made. The specific recognition criteria described below must also be met before revenue is recognised.

Sale of Products

Revenue from contracts with customers is recognised when control of the goods or services are transferred to the customer at an amount that reflects the consideration to which the Company expects to be entitled in exchange for those goods or services. Revenue is measured at the fair value of the consideration received or receivable, net of returns, discounts, volume rebates, and goods and service tax. The Company recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the Company regardless of when the payment is being made.

The specific recognition criteria described below must also be met before revenue is recognised.

Contract balances

Trade receivables

A receivable represents the Company's right to an amount of consideration that is unconditional (i.e., only the passage of time is required before payment of the consideration is due).

Refund Liabilities

A refund liability is the obligation to refund some or all of the consideration received (or receivable) from the customer and is measured at the amount the Company ultimately expects it will have to return to the customer. The Company updates its estimates of refund liabilities (and the corresponding change in the transaction price) at the end of each reporting period. Refer to above accounting policy on variable consideration.

Dividend income is recognized when the company's right to receive dividend is established. Interest income is recognized using the effective interest method. All other income are recognized on accrual basis.

c) Subsidy

Subsidy / Concession receivable on the Company's product are accounted when there is a reasonable assurance and certainty that such subsidy will be receivable and the company will be able to comply with the requirements attached with its realisation.

d) Property, Plant & Equipment

Property, Plant and Equipment are stated at cost, less accumulated depreciation and accumulated impairment loss, if any. The cost of Property, Plant & Equipment comprises of its purchase price, including import duties and other non-refundable taxes or levies and any directly attributable cost of bringing the asset to its working condition for its intended use. Interest and other financial charges on loans borrowed specifically for acquisition of capital assets are capitalized till the start of commercial production.

Depreciation is provided on the straight line method except for building which is provided on written down value method over the estimated useful lives of assets and are in line with the requirements of Part C of Schedule II of the Companies Act, 2013.

Advances paid towards the acquisition of property, plant and equipment outstanding at each balance sheet date is classified as Capital Advances under other Non-Current Assets and the cost of assets not put to use before such date are disclosed under 'Capital Work in Progress'.

The cost and related accumulated depreciation are eliminated from the Financial Statements upon sale or retirement of the asset and the resultant gains or losses are recognized in the Statement of Profit & Loss. The method of depreciation, useful lives and residual values are reviewed at each financial year end and adjusted prospectively, if appropriate.

Notes to Financial Statements as at and for the year ended March 31, 2026**e) Inventories**

Inventories are valued at cost or net realisable value whichever is lower. Closing stock has been valued on FIFO basis. Cost comprises expenditure incurred in the normal course of business in bringing such inventories to its location and includes, where applicable, appropriate overheads based on normal level of activity.

Net realisable value is the estimated selling price in the ordinary course of business, less estimated costs of completion and the estimated costs necessary to make the sale.

f) Financial Instruments**Initial recognition and measurement**

The Company recognizes financial assets and financial liabilities when it becomes a party to the contractual provisions of the instrument. All financial assets and liabilities are recognized at fair value on initial recognition, except for trade receivables which are initially measured at transaction price. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities, which are not at fair value through profit or loss, are added to the fair value on initial recognition. Regular way purchase and sale of financial assets are accounted for at trade date.

Subsequent measurement**i. Non derivative financial instruments****1) Financial assets carried at amortized cost**

A financial asset is subsequently measured at amortized cost if it is held within a business model whose objective is to hold the asset in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

2) Financial assets at fair value through other comprehensive income

A financial asset is subsequently measured at fair value through other comprehensive income if it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

3) Financial assets at fair value through profit or loss

A financial asset which is not classified in any of the above categories are subsequently fair valued through profit or loss.

4) Financial liabilities

Financial liabilities are subsequently carried at amortized cost using the effective interest method, except for contingent consideration recognized in a business combination which is subsequently measured at fair value through profit and loss. For trade and other payables maturing within one year from the Balance Sheet date, the carrying amounts approximate fair value due to the short maturity of these instruments.

ii. Derivative financial instruments

The Company holds derivative financial instruments such as foreign exchange forward and option contracts to mitigate the risk of changes in exchange rates on foreign currency exposures. Such derivative financial instruments are initially recognized at fair value on the date on which a derivative contract is entered into and are subsequently re-measured at fair value through profit or loss.

Derecognition of financial instruments

The company derecognizes a financial asset when the contractual rights to the cash flows from the financial asset expire or it transfers the financial asset and the transfer qualifies for derecognition under Ind AS 109. A financial liability (or a part of a financial liability) is derecognized from the Company's Balance Sheet when the obligation specified in the contract is discharged or cancelled or expires.

g) Fair Value Measurement

The Company uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximizing the use of relevant observable inputs and minimizing the use of unobservable inputs. All methods of assessing fair value result in general approximation of value, and such value may never actually be realized.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorized within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- i) Level 1 – Quoted (unadjusted) market prices in active markets for identical assets or liabilities.
- ii) Level 2 – Valuation techniques for which the lowest level input that is significant to the fair value measurement is directly or indirectly observable.
- iii) Level 3 – Valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable.

h) Impairment

Impairment is recognized based on the following principles:

Financial Assets

The Company recognizes loss allowances using the Expected Credit Loss (ECL) model for the financial assets which are not fair valued through profit or loss. Loss allowance for trade receivables with no significant financing component is measured at an amount equal to life time ECL. For all other financial assets, expected credit losses are measured at an amount equal to the 12 month ECL, unless there has been a significant increase in credit risk from initial recognition in which case those are measured at life time ECL. The amount of expected credit losses (or reversal) that is required to adjust the loss allowance at the reporting date to the amount that is required to be recognized is recognized as an impairment gain or loss in profit or loss.

Non-Financial Assets

Goodwill and intangible assets that have an indefinite useful life are not subject to amortization and are tested annually for impairment, or more frequently if events or changes in circumstances indicate that they might be impaired. Other assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognized for the amount by which the assets carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an assets fair value less costs of disposal and value in use. For the purpose of assessing impairment, assets are grouped at the lowest level for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash- generating unit) Non- financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at the end of reporting period.

i) Provisions

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.

Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount cannot be made.

j) Foreign Currency Transactions & Translations

The functional currency of the Company is Indian Rupee. These Financial Statements are presented in Indian Rupee.

Transactions in foreign currencies entered into by the Company are accounted at the exchange rates prevailing on the date of the transaction. Gains & losses arising on account of realization are accounted for in the Statement of Profit & Loss.

Monetary Assets & Liabilities in foreign currency that are outstanding at the year end are translated at the year end exchange rates and the resultant gain/loss is accounted for in the Statement of Profit & Loss.

k) Cash and Cash Equivalents

Cash and Cash Equivalent in the balance sheet comprise cash at banks and on hand and short-term deposits with an original maturity of three months or less, which are subject to an insignificant risk of changes in value.

l) Employee Benefits

Defined Contribution Plan

The Company makes contributions towards provident fund to the regulatory authorities to a defined contribution retirement benefit plan for qualifying employees, where the Company has no further obligations. Both the employees and the Company make monthly contributions to the Provident Fund Plan equal to a specified percentage of the covered employee's salary.

Defined Benefit Plan

The Company operates a defined benefit gratuity plan in India, comprising of Gratuity fund with an approved trust. The Company's liability is actuarially determined using the Projected Unit Credit method at the end of the year in accordance with the provision of Ind AS 19 - Employee Benefits.

The Company recognizes the net obligation of a defined benefit plan in its balance sheet as an asset or liability. Gains and losses through re-measurements of the net defined benefit liability/(asset) are recognized in other comprehensive income and are not reclassified to profit or loss in subsequent periods.

The Company recognises the changes in the net defined benefit obligation like service costs comprising current service costs, past-service costs, gains and losses on curtailments and non-routine settlements and net interest expense or income, as an expense in the Statement of Profit and Loss.

Short term employee benefits are charged off at the undiscounted amount in the year in which the related services are rendered.

Notes to Financial Statements as at and for the year ended March 31, 2026**Other long term employee benefits**

The Company treats accumulated leaves expected to be carried forward beyond twelve months, as long term employee benefit for measurement purposes. Such long-term compensated absences are provided for based on the actuarial valuation using the projected unit credit method at the end of each financial year. This benefit is not funded. Actuarial gains/losses are immediately taken to the Statement of Profit and Loss and are not deferred.

m) Borrowing Cost

Borrowing costs directly attributable to the acquisition, construction or production of an asset that necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of the asset. All other borrowing costs are expensed in the period in which they occur. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds. Borrowing cost also includes exchange differences to the extent regarded as an adjustment to the borrowing costs.

n) Income Taxes

Income tax expense is recognized in the Statement of Profit & Loss except to the extent that it relates to items recognized directly in equity, in which case it is recognized in other comprehensive income. Provision for current tax is made at the current tax rates based on assessable income.

Deferred income tax assets and liabilities are recognized for all temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the Financial Statements except when the deferred income tax arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and affects neither accounting nor taxable profit or loss at the time of the transaction. Deferred tax assets are reviewed at each reporting date and are reduced to the extent that it is no longer probable that the related tax benefit will be realized.

Deferred income tax assets and liabilities are measured using tax rates and tax laws that have been enacted or substantively enacted by the Balance Sheet date and are expected to apply to taxable income in the years in which those temporary differences are expected to be recovered or settled. The effect of changes in tax rates on deferred income tax assets and liabilities is recognized as income or expense in the period that includes the enactment or the substantive enactment date. A deferred income tax asset is recognized to the extent that it is probable that future taxable profit will be available against which the deductible temporary differences and tax losses can be utilized. Deferred income taxes are not provided on the undistributed earnings of subsidiaries and branches where it is expected that the earnings of the subsidiary or branch will not be distributed in the foreseeable future. The company offsets current tax assets and current tax liabilities, where it has a legally enforceable right to set off the recognized amounts and where it intends either to settle on a net basis, or to realize the asset and settle the liability simultaneously.

o) Earnings per Share

Basic earnings per share is computed by dividing the net profit for the period attributable to the equity shareholders of the Company by the weighted average number of equity shares outstanding during the period. The weighted average number of equity shares outstanding during the period is adjusted for events such as bonus issue, bonus element in a rights issue, share split, and reverse share split (consolidation of shares) that have changed the number of equity shares outstanding, without a corresponding change in resources.

For the purpose of calculating diluted earnings per share, the net profit for the period attributable to equity shareholders and the weighted average number of shares outstanding during the period is adjusted for the effects of all dilutive potential equity shares.

p) Recent Accounting Pronouncements

Ministry of Corporate Affairs ("MCA") notifies new standards or amendments to the existing standards under Companies (Indian Accounting Standards) Rules as issued from time to time. During the year ended March 31, 2026, MCA notified amendments to Ind AS 1 - Presentation of Financial Statements, Ind AS 7 - Statement of Cash Flows, Ind AS 107 - Financial Instruments: Disclosures, Ind AS 12 - Income Taxes and Ind AS 21 - The Effects of Changes in Foreign Exchange Rates, effective from April 1, 2025. The Company has assessed these amendments and concluded that they do not have a material impact on its financial statements

(iii) Financial risk management objectives and policies
Financial risk factors

The Company's activities expose it to a variety of financial risks: (a) market risk,(b) liquidity risk & (c)credit risk which may adversely impact the fair value of its financial instruments. The Company's focus is to foresee the unpredictability of financial markets and seek to minimize potential adverse effects on its financial performance.

(A) Market risk

Market risk comprises interest rate risk & foreign currency risk. Financial instruments affected by market risk include loans and borrowings in foreign currencies.

(a) Interest rate risk

The Company is exposed to interest rate risk because the Company borrow funds both at fixed and floating interest rates. The risk is managed by the Company by maintaining an appropriate mix between fixed and floating rate borrowings. The Company's exposure to the risk of changes in market interest rates relates primarily to the Company's long term debt obligations with floating interest rates.

(b) Foreign currency risks
