Further to our letter dated December 11, 2025, we hereby inform that we have received communication dated May 05, 2026 from Mr. Vivek Kumar Ratakonda, the prospective Resolution Applicant (RA), that the Hon'ble National Company Law Tribunal, Hyderabad Bench ("NCLT"), vide its Order dated May 5, 2026, *inter alia*, directing the Resolution Professional (RP) to take into account the contentions raised by the RA. He has further stated that the matter of Baron Infotech Limited cannot be finalised until all the contentions raised by Mr. Ratakonda are considered by the RP and appropriately disposed off by the Hon'ble NCLT. We wish to explicitly state that Resolution Plan approved by Committee of Creditors (CoC) cannot be considered final till it is approved by NCLT and in this case it is not approved till date.

Mr. Ratakonda has further updated about the Corporate Announcement at BSE made by the RP of Baron Infotech Limited, intimating the filing of Resolution Plan with Hon'ble NCLT, Hyderabad Bench. However, they have not informed BSE about the aforesaid Order of NCLT in respect of the contentions raised by RA before the NCLT. Hence, the intimation of RP to BSE doesnot give complete picture with full transparency.

You are requested to kindly take the same on records and do the needful.
