UPON hearing the counsel the Court made the following
O R D E R

1. Heard Mr. Gopal Jain, learned Senior Counsel for the petitioner and Mr. Aniruddha Anant Joshi, learned Senior Counsel for respondent No.1.

2. Both parties on suggestion of the Court have agreed that an attempt should be made to thrash out the dispute through the mediation. However, the mediation will be without prejudice to the rights and contentions of the parties.

3. Though only respondent No.1 is appearing, Mr. Aniruddha Anant Joshi, learned Senior Counsel submits that the other respondents are part of the same group and have no objection to participate in the mediation.

4. Considering the nature of the dispute, we request Hon'ble Mr. Justice Abhay S. Oka, Former Judge of this Court to mediate the dispute between the parties. The learned Mediator is at liberty to fix the terms after discussing with the parties.

5. Both parties submit that pending mediation, they will make a joint request to postpone the hearing of the suit till the mediation report is received and this Court makes further orders in this matter. Both parties also undertake that they will not precipitate the issue any further pending the mediation.
