During June 2026, the Company secured consolidated orders worth **₹33.79 crore**, led by the Pharma sector (**₹20.36 crore**), followed by Others (**₹8.98 crore**) and Renewable Energy (**₹4.45 crore**). From a business vertical standpoint, **₹17.81 crore** was contributed by HVAC Systems and **₹15.98 crore** by Cleanroom Partitions.
2. As of **30 June 2026**, our consolidated order book stands at **₹362.41 crore**, comprising Renewable Energy (**₹177.63 crore**), Pharma (**₹147.40 crore**), Data Centres (**₹26.74 crore**), Semiconductors (**₹0.50 crore**), and Others (**₹10.14 crore**).
3. Orders under active consideration total **₹514.78 crore**, with major opportunities in Pharma (**₹229.01 crore**), Renewable Energy (**₹269.00 crore**), Data Centres (**₹12.00 crore**), and Others (**₹4.77 crore**).
