A W A R D

1. Heard Mr. Pradeep Kumar Yadav, learned counsel appearing for the petitioner and Mr. Surya Kamal Mishra, learned counsel for the respondent No.2-Insurance Company.

2. We have also interacted with Mr. Bali Ram, the petitioner over video conferencing who is present with the Secretary, District Legal Services Authority, Balwani.

3. The parties have arrived at a settlement during the course of hearing. It is agreed that respondent No.2-Insurance Company shall pay a consolidated amount of Rs.31,00,000/- (Rupees thirty one lakhs) over and above the amount awarded by the High Court to the petitioner in full and final settlement of all his claims. The petitioner agrees that on receipt of the consolidated amount of Rs.31,00,000/- (Rupees thirty one lakhs) over and above the amount awarded by High Court, the petitioner will have no further claim whatsoever against the respondent No.2-Insurance Company.

3. The additional compensation of Rs.31,00,000/- (Rupees thirty one lakhs) shall be paid to the petitioner. The petitioner shall furnish the account details to the respondent-Insurance Company. On due verification, the amount of Rs.31,00,000/- (Rupees thirty one lakhs) shall be directly transferred to the petitioner within a period of 30 days.

4. We place on record our appreciation for the learned counsel for the parties, Mr. P.N.Arun, Deputy General Manager, Ms. Rekha Mathur, Regional Manager and Mr. Sunil Saini, Assistant Manager, United India Insurance Company for the positive and spontaneous response they have shown in settling the matter.

5. The Special Leave Petition is disposed of in the above terms.
