Pursuant to the provisions of Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and further to our letter dated June 4, 2026 in respect of seizure of stock by FSSAI Maharashtra, we wish to update you on the following development in the matter.

The Company had filed Writ Petition before the Hon'ble High Court of Delhi at New Delhi seeking relief. The High Court has granted Interim Stay to the impugned notice of FSSAI, New Delhi and has allowed Eight months' time to exhaust its existing stock bearing the descriptors 'electrolyte'/'electrolyte drink' and to make required changes to the labels.

The detailed disclosure in the format prescribed under SEBI Circular no. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 is enclosed as Annexure – A to this letter.

There is no material adverse impact on the financials, operations or other activities of the Company on account of the above order.
