Dear Sir / Madam,

This is in reference to the application submitted by Abhishek Infraventures Ltd ("Company") for seeking Reclassification of Promoter Shareholders under the provisions of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, (LODR) wherein Regulation 31A(8)(c) states that:

"The following events shall deem to be material events and shall be disclosed by the listed entity to the stock exchanges as soon as reasonably possible and not later than twenty-four hours from the occurrence of the event:

(c) submission of application seeking no-objection or approval of the recognized stock exchanges for re-classification of status as public by the listed entity to the stock exchanges..."

It has been observed that the Company has disclosed such event with the Exchange on May 21, 2026. However, disclosure regarding the same should have been submitted on November 19, 2025.

Hence, it is observed that the timelines stipulated under Regulation 31A(8)(c) have not been adhered to. Accordingly, you are hereby advised to be careful in future, exercise due caution and initiate corrective steps to avoid recurrence of such incidence to ensure due compliance with the Exchange circulars/guidance/communications.


