ORDER

1. The present Transfer Application has been filed seeking the following reliefs:

“a. Transfer / re-assign Company Petition (IB) No. 446 (MB) of 2023 and/or Company Petition (IB) No. 620 (MB) of 2023 pending before Court-V and Court-IV respectively to be listed before any one of the two Co-ordinate Bench of the Hon'ble National Company Law Tribunal, Mumbai Bench for just, fair and swift disposal of the Petitions in light of the pending 12A Applications in the matter as deemed fit and proper by this Hon'ble Tribunal;

b. Pass any such other and further order(s) as this Hon'ble Tribunal may deem fit and proper in the facts and circumstances of the present case.”

2. This transfer application is for the consolidation of the cases, which are pending adjudication before different courts in Mumbai to one court for the proper adjudication of the matter, and to avoid conflicting orders. Ld. Counsel for the Respondent Nos. 1 & 2 submits that he has no objection if the petitions are transferred and both cases are heard and decided by one bench.
3. The remaining Respondents are stated to have been served. The Applicant has filed an affidavit of service as well, but no one has put in appearance on their behalf. Even on earlier occasions, no one has put in appearance for the remaining Respondents.
4. In view of the above, TA (IBC)-69(PB)/2025 stands allowed and disposed of. The Company Petition No. 446/MB/2023 pending before Court – V, NCLT, Mumbai Bench stands transferred to Court - IV, NCLT, Mumbai Bench.
