Opinion

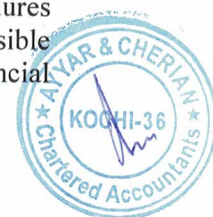
The Board of Directors are also responsible for overseeing the financial reporting process of the Company.
