1. Leave granted.
2. Appellant challenges the judgment and order dated 08.08.2024 in LPA No.1350/2024 (O&M) passed by the High Court of Punjab & Haryana at Chandigarh, titled "*Paramjit vs. Industrial Tribunal, Gurdaspur & Anr.*".
3. Having heard and perused the material available on record, we dispose of the present appeal with a modification of the impugned order in the following terms:
 - a) The appellant shall be entitled to a sum of Rs.2,50,000 (Rupees two lakh fifty thousand only) as lump sum, which the respondent shall pay to the appellant within a period of four weeks from today.
 - b) The said amount shall be directly remitted into the bank account of the appellant. The particulars whereof shall be supplied by the learned counsel for the appellant to the learned counsel for the respondent within a period of one week.

c) If the amount is not deposited within the said period, interest at the rate of six percent per annum shall be payable thereupon.

4. Pending application(s), if any, shall stand disposed of.
