**UPON hearing the counsel the Court made the following
O R D E R**

1. Issue notice on I.A. No.114621/2026 seeking impleadment of proposed respondents 5 to 10.
2. Upon receipt of notice, the proposed respondents 5 to 10 may file their counter affidavit. Such affidavit must be filed at least 72 hours prior to the next date of listing.
3. Learned senior counsel appearing for the petitioner, on instructions, volunteers to deposit Rs.62,06,592/- with the District Magistrate, Ghaziabad by tomorrow i.e. 25th August, 2026 without prejudice to the rights and contention of the parties.
4. Upon such deposit being made, the District Magistrate shall invest the same in a fixed deposit interest bearing account of a nationalized bank, on auto renewal basis.
5. Till the next date of hearing, no coercive action be taken against the petitioner subject to deposit of the amount as aforesaid.
6. List the special leave petitions along with I.A. No.114621/2026 after four weeks.
