O R D E R

1. The matter was adjourned owing to a mention being made in Court on the day the review petitions were listed, viz., 28.07.2026, that steps would be taken to cure the defects therein. However, despite the matter being adjourned for over a month, no steps were taken to cure the defects.
2. A mention was made in Court on 07.09.2026 seeking permission to cure the defects, as the matter was to be listed on 08.09.2026. Permission was granted but now, as per the

office report dated 07.09.2026, only some of the defects in the review petitions have been cured and several defects still remain uncured. As more than sufficient time has been granted to the review petitioners to do the needful in this regard, we see no reason why further time should be granted at this stage.

3. Even on merits, we find no grounds made out to review the judgment dated 07.11.2025 allowing the appeals filed by the Indian Railways Catering & Tourism Corporation Ltd. and dismissing the appeals filed by the caterers, viz., M/s. Brandavan Food Products, R.K. Associates and Hoteliers Pvt. Ltd. and Satyam Caterers Pvt. Ltd.
4. The review petitions are, accordingly, dismissed.

Pending applications shall stand disposed of.
