O R D E R

1. The petitioner challenges the judgment and order dated 20.05.2026 in SAD No.426/2021 titled "*Uttar Pradesh State*

Warehousing Corporation & Ors. vs. Arjun Kumar Singh & Ors."

passed by the High Court of Judicature at Allahabad.

2. As orally prayed, Mr. Maheshwari Prasad Rai, S/o Sri Ram jee Rai, R/o 441/D, Buxi Khurd, Daraganj, Allahabad is impleaded as a party-respondent. The cause title be amended accordingly.

3. Issue notice, returnable on 15.09.2026.

4. Mr. Abhishek Gupta, learned Advocate-on-Record, appears on caveat and accepts notice on behalf of respondent nos.1 and 11. Mr. Rahul Gupta, learned Advocate-on-Record, accepts notice on behalf of the newly impleaded respondent. Ms. Tulika Banerjee, learned Advocate-on-Record, accepts notice on behalf of the State/respondent no.13. Hence, service of formal notice on the said respondents is waived. Let notice be issued to the remaining respondents.

5. Dasti service, in addition, is permitted. Let steps for service be taken within two weeks.

6. In the notice itself, let it be mentioned that respondents are required to file their counter affidavit and reply to the interlocutory application(s), if any, before the next date of listing.

7. Let counter affidavit be filed within four weeks. Rejoinder thereto, if any, be filed within two weeks thereafter.

8. In the meanwhile, the operation of the directions contained in the paragraph 20(ii) of the impugned judgment and order dated 20.05.2026 passed by the High Court of Judicature at Allahabad in SAD No. 426 of 2021 shall remain stayed.
