Dear Sir / Madam,

1. Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with the applicable provisions of Schedule III and the circulars issued thereunder, we wish to inform the Exchange that the Company has received a demand notice dated **01<sup>st</sup> July, 2026** under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (the “SARFAESI Act”) from the Kolhapur District Central Co-operative Bank Limited (KDCC Bank), calling upon the Company to pay a sum of Rs. **2440.07 Lacs** within sixty days, in respect of deed of mortgage dated 17/10/2024 registered at sr. no. 4901/ 24 in the favour of bank and created securities on that piece and parcel of the Land being Gat no. 990/1 situated at Bhadgaon, Gadinglaj, Kolhapur thereon,. The notice was received by the Company on 08<sup>th</sup> July, 2026.
2. The Company does not accept the demand as raised and is contesting the notice. The Company is contesting the action on the ground, among others, that it is not in accordance with the framework for revival and rehabilitation of micro, small and medium enterprises applicable to the Company’s account, which is required to be followed before the account of an eligible enterprise is classified as non-performing and enforcement measures are initiated. The Company is pursuing the remedies available to it in accordance with law.
3. The notice received by the Company is a demand notice under Section 13(2) of the SARFAESI Act, and no measures under Section 13(4) of the SARFAESI Act have been initiated. The Company is taking appropriate steps to resolve the matter and will keep the Exchange informed of any material developments.
