**Report on the Audit of the Financial Results**

**Opinion**

We have audited the accompanying Quarterly Financial Results of VISTAR AMAR LIMITED ("the Company"), for the quarter ended 31st March 2026 and year-to-date results for the period from 1<sup>st</sup> April 2025 to 31<sup>st</sup> March 2026, attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015, as amended (the 'Listing Regulations').

In our opinion and to the best of our information and according to the explanations given to us, these annual financial results:
