1. I Sarika Kulkarni, Proprietor of Sarika Kulkarni & Associates, Company Secretaries, Chh. Sambhajinagar was appointed as the Scrutinizer by the Board of Directors of Endurance Technologies Limited ("the Company") pursuant to the provisions of Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014, to scrutinize the votes cast through electronic means ("Remote E-voting") on the item of the business set out in the Notice of Postal Ballot dated 16th April, 2026 issued by the Company.

Ltd ("MUFG Intime") Registrar & Transfer Agent of the Company or the respective Depository Participants as on Cut-off Date 24th April 2026.
3. In terms of Regulation 47 of the Listing Regulations and pursuant to Rules 20 & 22 of the Rules, the Company had published an advertisement intimating about the voting on the business set out in the Notice of Postal Ballot through electronic means and dispatch of the said Notice, in English language in Newspaper viz. 'Financial Express' and in Marathi language in Newspaper viz. 'Loksatta,' both dated 30th April 2026 having circulation country-wide and in Chh. Sambhajinagar, respectively.
4. In compliance with Regulation 44 of the Listing Regulations and pursuant to Sections 108 and 110 of the Act read with Rules 20 and 22 of the Rules, the Company had provided Remote E-voting facility to cast votes on the resolution through the electronic voting platform of National Securities Depositories Limited ("NSDL").

- Members were required to communicate their assent or dissent only through the Remote E-voting system as the hard copy of Notice of Postal Ballot along with Postal Ballot Form and pre-paid business reply envelope were not sent to the Members for this Postal Ballot pursuant to MCA Circulars.
- The Remote E-voting period commenced at 09.00 am (IST) on Monday, 4th May 2026 and concluded at 05.00 pm (IST) on Tuesday, 2nd June 2026 at the e-voting platform on the designated website of NSDL i.e. www.evoting.nsdl.com. E-voting facility was blocked immediately thereafter.
- I monitored the process of Remote E-voting through the scrutinizer's secured link provided by NSDL through its designated website.
- After completion of Remote E-voting, votes cast by the Members were unblocked by me in the presence of two witnesses, Mr. Abhijit Kulkarni and Mrs. Mohini Joshi who are not in the employment of the Company.
