A W A R D

1. Heard Mr. Chitta Ranjan Mishra, learned counsel appearing for the petitioners and Mr. Abhishek Gola, learned counsel for the respondent Insurance Company instructed by Mr. Deepak Gupta, Deputy General Manager. The parties have arrived at a settlement during the course of hearing.

2. It is agreed that respondent-Insurance Company shall pay a further amount of Rs.5,00,000/- (Rupees five lakhs) over and above the amount awarded by the High Court to the petitioners in full and final settlement of all their claims. The petitioners agree that on receipt of the consolidated amount of Rs.5,00,000/- (Rupees five lakhs) over and above the amount awarded by High Court, the petitioners will have no further claim against the Insurance Company.

3. The additional compensation of Rs.5,00,000/- (Rupees five lakhs) shall be paid to the petitioners. The petitioners shall furnish the account details to the respondent. On due verification, the amount of Rs.5,00,000/- (Rupees five lakhs) shall be transferred to the petitioners within a period of 30 days.

4. The Special Leave Petition is disposed of in the above terms.

5. We place on record our appreciation for Mr. Abhishek Gola, learned counsel and Mr. Deepak Gupta, Deputy General Manager for the positive and spontaneous response they have shown in settling the matter.
