Issue a direction or a writ in the nature of mandamus and/or any other appropriate writ, directing the offices of Respondent No. 1 to deploy adequate police personnel near the Petitioner's kiosk area at the Dehradun Airport premises to ensure safe commencement and uninterrupted continuation of the Petitioner's services, whenever any such representation is made by the authorised personnel of the Petitioner;</i></p> <p><i>III. Issue an order or a direction in the nature of permanent injunction, restraining Respondent No. 5 (Jolly Grant Airport Taxi Chalak and Owner Samiti), its</i></p> |

|  |  |  | <p><i>members, agents, and all persons acting for and on its behalf from: (i) obstructing and blocking the cars of the driver-partners of the Petitioner and/or hampering or interfering in the legitimate business of the Petitioner and causing violence of any nature; (ii) from being present at and protesting in any manner around the Petitioner's designated kiosks; (iii) from interacting with the Petitioner's employees/personnel and its driver-partners in any manner; and (iv) instigating others to agitate against the Petitioner and its driver-partners."</i></p> <p>4. Learned State Counsel rightly points out that in case petitioner is facing any threat from the Taxi Union, then he can approach the SHO of the jurisdictional police station.</p> <p>5. The writ petition is disposed of with liberty to petitioner to approach the SHO concerned by making a complaint.
