(b) The PBT and PAT figure has been corrected. Accordingly, the revised Consolidated XBRL financial results have been submitted with the corrected figures.

(c) The Paid up equity Share capital has been corrected. Accordingly, the revised Standalone and Consolidated XBRL financial results have been submitted with the corrected figures.

(d) The Reserves excluding revaluation reserve figures has been Mentioned. Accordingly, the revised Standalone and Consolidated XBRL financial results have been submitted with the corrected figures.

(e) The Cash Flow Statement figures has been corrected. Accordingly, the revised Standalone and Consolidated XBRL financial results have been submitted with the corrected figures.
