Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, we hereby inform you that the Company has received a Show Cause Notice cum Order in Form GST DRC-01, dated 22nd August 2026, issued by the State Taxes Officer, Kashmir, Jammu and Kashmir, under Section 129(3) of the CGST Act, 2017, in respect of detention of goods found in transit without a valid E-Way Bill and valid tax invoice.

The Company has voluntarily paid the penalty of ₹ 4,01,400/- levied under the said order, for which appeal filing is under process with appropriate authorities.
