**ORDER**

Present: Shri. Chethan Sagar, Ld. Counsel for the Applicant/RP.

Memo filed by the Applicant pursuant to the order dated 22.06.2026 enclosing the minutes of the 28<sup>th</sup> CoC meeting held on 25.05.2026.

It is seen that on an appeal filed by the suspended director before Hon'ble NCLAT, the CIRP order dated 12.12.2023 passed by the Tribunal was deferred till 07.03.2024 on which date the appeal was dismissed. Thereafter, the suspended director filed an appeal before Hon'ble Supreme Court against the order of the Hon'ble NCLAT where by order dated 24.03.2025, Hon'ble Supreme Court directed that CIRP may be proceeded with but the proceedings for approval of the resolution plan may be done with the approval of the Hon'ble Supreme Court. On 05.01.2026, Hon'ble Supreme Court permitted the 8 resolution plans received to be scrutinized and the CoC to consider and approve the appropriate plan for the Corporate Debtor with further directions to the Tribunal not to consider the application for approval for the resolution plan till further orders.

Ld. Counsel submits that the plan was placed before the CoC where the CoC with more than 66% voting, approved the resolution plan on 16.02.2026.

In the instant case, exclusion has been pleaded for the period from 10.07.2025 to 30.05.2026.

Ld. Counsel submits that the application seeking approval of the plan has been filed before this Tribunal and is listed for hearing on 02.07.2026.

The RP is directed to explain on what basis he is seeking exclusion upto 30.05.2026.
