This is in reference to our earlier communication dated 29th April, 2025 (copy enclosed for reference), regarding approval of capital expenditure for setting up a greenfield manufacturing plant at Mindewadi, Taluka Maval, District Pune, Maharashtra. In continuation thereto, we would like to update that the said manufacturing facility has commenced commercial production of Lithium Ion Battery packs effective from today i.e. 17th June, 2026.

The initial installed capacity of the plant is to manufacture ~26,000 Lithium Ion Battery packs per month, expandable up to ~35,000 per month. The plant has been strategically designed to support future capacity expansion by installing balance equipment. This expansion will be initiated when the Company secures further orders from its OEM customers.
