The instant application has been filed by the applicants/claimants praying for withdrawal of the 50% of the awarded amount deposited by the appellants before the Registry of this Court in compliance with the order dated 22.05.2026 in I.A(Civil) No.116(K)/2025.

Ms. Thuyekhrulu, learned counsel is present for the applicants/claimants and submits that the said amount has

already been deposited by the appellant before the Registry. The learned counsel further submits that the applicants are in dire need of the compensation amount and prays that the same may be released.
