UPON hearing the counsel the Court made the following  
O R D E R

1. The present Special Leave Petition arises out of three orders dated 10.06.2026, 15.06.2026 and 09.07.2026 passed by the High Court of Delhi in Cont. Cas(C) No. 1043 of 2026.

2. Mr. Mukul Rohatgi, learned senior counsel appearing for the

petitioner submits that the directions in these orders have a serious financial implication on the petitioner/plaintiff in the suit. Mr. Rohatgi therefore seeks interim direction pending disposal of the Special Leave Petition.

3. We are not inclined to interfere with the orders impugned before us. We would, however, request the High Court to advance the listing of the application for recalling the order dated 10.06.2026, which is directed to be listed on 11.09.2026 to someday before the end of this month.
