**ORDER**

1. The instant transfer application has been filed seeking transfer of C.A.(CAA)/38(KB)2024 from the Court-II, NCLT, Kolkata Bench to Court-I, NCLT, Mumbai Bench.
2. Ld. Counsel appearing for the Applicant submits that the first motion petition bearing no. C.A. (CAA)-250/2022 filed by the Transferor Company was allowed by NCLT, Mumbai Bench vide order dated 16.01.2024, whereas the first motion petition bearing no. C.A. (CAA)-38(KB)/2024 filed by the Transferee Company was allowed by NCLT, Kolkata Bench vide order dated 30.10.2024. During the pendency of C.A. (CAA)-38(KB)/2024, the Board of Directors of Transferee Company passed a Board Resolution on 30.05.2024 for shifting its registered office from West Bengal to Maharashtra.
3. The Transferor Company has also preferred second motion application bearing no. CP (CAA)/176/MB/2025 in NCLT, Mumbai Bench which was allowed vide order dated 05.03.2026.

4. Notice has been issued to the Statutory Authorities / Non-Applicants and affidavit of service has been filed.
5. No one has put in appearance on behalf of the Statutory Authorities / Non-Applicants. Even on the last date of hearing, no one has put in appearance on behalf of the Statutory Authorities / Non-Applicants.
6. Heard.
7. It is apparent that the office of the Transferor Company is in Maharashtra and now the office of the Transferee Company has also been shifted to Maharashtra vide Board Resolution. The first motion as well as the second motion petition had been allowed by the NCLT, Mumbai Bench, therefore, it would be appropriate that the C.A. (CAA)-38(KB)/2024 pending before Court-II, NCLT, Kolkata Bench be transferred to Court-I, NCLT, Mumbai Bench.
8. Consequently, **TA (Co. Act)-07(PB)/2026 stands allowed and C.A. (CAA)-38(KB)/2024 stands transferred from the Court-II, NCLT, Kolkata Bench to Court-I, NCLT, Mumbai Bench.**
